The following Federal Acquisition Regulations (FARs) and Defense Federal Acquisition Regulations Supplement (DFARS) clauses are incorporated if contract N68520-20-D-0002 and/or its associated Task Order/Delivery Order is cited. Within these clauses, the term "Contractor" shall mean Subcontractor, the term "Contract" shall mean its Subcontract or Purchase Order, and the terms "Government," "Contracting Officer" and equivalent phrases shall mean the ACE equivalent, respectively. The referenced clauses shall apply to Subcontractor or Vendor in such manner as is necessary to reflect the position of Subcontractor as a Subcontractor to ACE, to insure Subcontractor's obligations to ACE and to the United States Government, and to enable ACE to meet its obligations under its Prime Contract. It is a material part of these Terms and Conditions that govern any Purchase Order/Subcontract issued by ACE pursuant to a Government contract, that the vendor/subcontractor shall include the appropriate FAR and DFARS flow down clauses in each lower-tier purchase order or subcontract. Failure to do so may constitute a material breach of these Terms and Conditions. All clauses should be updated to the most current and active under regulations.
